

NOTICE TO THE EXHIBITORS

Police regulation, article 1, 14 october 2009

During the event called “Bourse Militaria” organized in “Marché Couvert” of Ciney and in CINEY EXPO, it will be absolutely forbidden to expose any object representing the emblem SS or Nazi (swastika), except to demonstrate that this object presents value of historic collection.

Extract from the Belgian Law regarding fire arms (9/06/2006) – (See www.cineyexpo.be)

Summary from the circular on the implementation of the gun laws (29/10/2010) !!!!!!!

- You are a Belgian or foreign exhibitor, private or collector, and you present free fire weapons in Belgium for sell without commercial target, NOT necessary to have a license of gun dealer.
- You are a Belgian, private or collector, and you present free fire weapons in Belgium for sell with commercial target, OBLIGATION to have a license of gun dealer.
- You are a foreign exhibitor, private or collector, and you present free fire weapons in Belgium for sell with commercial target, OBLIGATION to have a temporary Belgian license of gun dealer. In this case:
 - Introduction of the request for temporary Belgian license of gun dealer to the weapons services of the Governor of the Province of first place fair of the year you participate.
 - 4 to 5 weeks before the fair, you must send to the organizer (and not directly to the service of weapons licenses) a list of free fire weapons in Belgium that you'll present + copy of your temporary Belgian license of gun dealer. After this, no more weapons can be added to the list.
- You must present each weapon to the Tests Bench of Liège Belgium (for Belgian exhibitor, take an appointment; for the foreign exhibitor, the tests Bench will give the certificates of fire weapons in the period between 3 weeks and 1 week before the fair (*).
- The day of the fair, you must hold a book with bound pages to list the fire weapons for sale and sales (**).
- At the end of the fair, you must give to the organizer (he has a photocopier) a copy of the pages with sales of the day. Otherwise, you have 3 working days to give this copy to the organizer.

(*) All name, address and telephone numbers of the provincial governments, the licenses department of each Regions, the tests bench of Liège,... are available from the organizer.

(**) On your request, we can also give you an example of the fire weapons list that you have to give, but also an example of book with bound pages.

At least, all the fire weapons that are allowed in Belgium are included in a complete list that is available on our website or on request (+32(0)83/21.33.94 or angelique@cineyexpo.be).

Prohibited weapons in Belgium (Seer info on www.cineyexpo.be)

Are also prohibited out of fair, the ammunition in operating condition, as well as the casings and the projectiles, unless they were not made inapt for the shooting.

The presence of weapons and/or ammunition subjected to authorization at the time of this fair will not be tolerated.

The weapons that will not be presented to bench test of Liege will not be tolerated.

The access to the fair « Militaria » is forbidden with the minors (- 18 years old) not accompanied.
