## CINEY MILITARIA - 25th OCTOBER 2020 - NOTICE TO EXHIBITORS Basic rules to be observed

1. Entry is forbidden to any minors unaccompanied by an adult.

2. It is forbidden to exhibit any object bearing the SS or Nazi emblem (swastika), unless it is to demonstrate that the object in question has a value as part of a historical collection (Police Regulations, April 2005, Article 1). In this case, the emblem must be hidden.

3. No live firearms may exhibited or sold, with the exception of those built before 1895.

4. Firearms desactivated prior to 8 April 2016 by the Liège proof house MAY NO LONGER be offered for sale at fairs, unless the firearms were deactivated after that date and carry the European deactivation mark.

## 5. The sale of magazines is prohibited, regardless of the firearm (law of 07/01/2018).

6. Only non-prohibited blank firearms, replica firearms, alarm guns (BEL stamp), flare pistols (if impossible to fire a gas or ball cartridge) are authorised.

7. All explosive devices (e.g. mortars, grenades, incendiaries, missiles, light anti-tank weapons (LAW)), whether or not they be inactive, empty, for training purposes or in good/poor condition, are forbidden.

8. Regarding the presence and sales of sockets and military ammunition with a caliber greater at .50. The sale will only be accepted if it is possible to see immediately and visually they are empty.

## 9. Signal guns cannot be put on sale because they are only available off-the-shelf on the sole condition that legitimate grounds for possessing them can be justified, grounds which are difficult to prove at a show of Militaria.

10. The following are prohibited and banned in Belgium :

1. anti-personnel mines and snares or devices of whatever nature, and laser-blinding weapons;

2. incendiary weapons;

3. weapons designed exclusively for military use, such as automatic firearms, launchers, artillery guns, rockets, weapons using forms of radiation other than those referred to under point 1, ammunition designed specifically for these weapons, bombs, torpedoes and grenades;

4. cluster munitions;

5. switch-blades and knives with spring-loaded blades, butterfly knives, knuckle-dusters and blank firearms which have the appearance of another object;

6. swordsticks and cane rifles which are not decorative, historical weapons;

7. bludgeons and batons;

8. firearms of which the butt or barrel can be disassembled into several sections, firearms manufactured or modified in such a way that they can be carried invisibly or less visibly, or so that their technical characteristics no longer correspond to the those of the model defined in the authorisation to possess the weapon, and firearms which have the appearance of an object other than a weapon;

9. portable devices which enable one to subdue people or cause them pain by means of an electric shock, with the exception of medical or veterinary devices;

10. objects designed to affect people by means of toxic substances, asphyxiants, tear gas and similar substances, with the exception of medical devices;

- 11. folding guns with a calibre above 20;
- 12. throwing knives;
- 13. nunchucks;
- 14. throwing stars;
- 15. the following devices and accessories, in particular :
  - silencers;
    - magazines;
    - sighting equipment for a firearm which projects a beam onto the target;
  - mechanisms allowing one to convert a firearm into an automatic firearm;

16. night-vision goggles.

Exhibitors who do not comply with these rules will be required to close their stand immediately and will be excluded from militaria fair of Ciney.
